Commonwealth Economic Development Authority INVITATION TO SUBMIT QUALIFICATIONS

To join a **pre-approved contractor list** for providing legal consultation on setting up businesses in the CNMI under the State Small Business Credit Initiative (SSBCI) Technical Assistance (TA) Grant Progam.

1. Purpose

The Commonwealth Economic Development Authority (CEDA) through the SSBCI TA Grant Program is seeking Statements of Qualifications from licensed attorneys and law firms interested in being included on a pre-approved contractor list to provide legal consultation services related to business formation and establishment in the Commonwealth of the Northern Mariana Islands (CNMI), with a focus on those owned by Socially and Economically Disadvantaged Individuals (SEDI) and Very Small Businesses (VSBs).

II. Background

The SSBCI TA Grant Program, funded by the U.S. Department of the Treasury, aims to expand access to capital and support small businesses through technical assistance. The CNMI has received funding to implement this program locally and is establishing a pool of qualified service providers to deliver legal consultation services.

III. Scope of Services

Selected attorneys will provide legal guidance and consultation in areas including, but not limited to:

- Business entity formation (corporations, LLCs, partnerships)
- Licensing and permitting requirements
- CNMI-specific regulatory compliance
- Foreign investment and immigration considerations
- Real estate and lease agreements
- Employment law and labor compliance

IV. Eligibility Requirements

Respondents must meet the following minimum qualifications:

- Licensed to practice law in the CNMI or eligible for temporary practice under CNMI law
- Demonstrated experience in business law, preferably within the CNMI or similar jurisdictions

• No conflicts of interest with the CNMI government or affiliated entities

Submissions will be evaluated based on:

Understanding of CNMI legal and business environment	25
Cost-effectiveness of proposed rates	20
Professional references and reputation	25
